On March 24, 2022, the Macon Bibb Citizen Advocacy Board hosted a community event at the Georgia Sports Hall of Fame. ### THE HEART OF CITIZEN ADVOCACY: GARY'S GIFT TO ME

After twelve years of friendship, I laid to rest my dearest friend, Gary. He had recovered from Covid, but he was in and out of the hospital with a serious infection and wounds that would not heal. His last days were spent at home with us. I was thankful to be there for Gary and his mother Lois every step of the way. As I sit here reflecting on our friendship, many things come to mind. His smile. Oh, how I am going to miss his smile. To see him smile, he lit up the room. He was a unique person with one of the most joyful spirits of compassion for others. He became someone special in my life, yet he showed me how much he appreciated me. Small moments were big moments to Gary. I would show up every week, and without fail, Gary would announce loudly "Yeah! Chris is here!" I truly mattered to Gary, and boy I hope Gary knew how much he mattered to me.

I was asked by Citizen Advocacy in 2010 to be a friend to Gary and to provide protection and advocacy when needed. His mother who is the bedrock of the family and sole protector wanted more allies in his life. Gary's good heart saw good, even when it was bad. He had not experienced a lot of kindness from others and has even experienced abuse because of having a disability. Over the years I proved my worthiness with building bonds of trust and solidarity with both Gary and Lois.

Gary knew he was cared for and deeply loved. When asked to use one word to describe my relationship with Gary, it was hard to do because there are so many words. But if I had to narrow it down to one, it would be the word "Hope". Having someone there to care because of who you are, you see the world with a glimmer of hope. To identify with another person's situation, you break down walls and barriers inside of you seeing what other people deal with in this world. Gary taught me more about love. He was training and preparing me for something greater. A gift.

Gary's gift to me is his family. Gary was all about family. Our deepest conversations were about family and God. He had unwavering faith. The last time I looked him in the eyes, he was tired, but he trusts me. We had a connection that was a real connection of I get you and you get me too. I knew what Gary wanted me to do. So, since his passing, I go over to his home every Thursday with my guitar for bible study and sing songs with his niece and nephew and to be there for his mom Lois. I'm doing what Gary would want me to do.

I thank Gary for the gift he's given me, I am going to carry out his wishes of family and God. Citizen advocacy is unique, making opportunities for relationships with people meeting one another who would not have met otherwise. That's beautiful.

### **Board Member Spotlight: Mr. Antwain Deal**



Antwain Deal grew up in Macon, GA and graduated from Westside High School. While in high school he was captain of the bowling team, and even won a state championship. After high school he worked for the City of Macon's AmeriCorps program while attending college at Macon State. AmeriCorps is where his love for community truly grew. He also served as Treasure of Internal Audit Association and President of a student organization called B.O.L.D (Brothers of Leadership and Distinction). After college, Antwain worked for a publicly sold company in the Railcar industry for three years as an accounting controller and internal audit lead. Nowadays, his passions are still focused on community and mentorship, and he believes that MBCA is the best way to make an impact on our communities' quality of life .

# HOW DOES CITIZEN ADVOCACY WORK?

A valued citizen, who is unpaid and independent of the human service system, is invited by citizen advocacy coordinators into a relationship with a person who is living with a disability and is vulnerable to abuse, neglect, or social isolation. With the coordinator's support, the citizen advocate learns to understand, respond to, and represent that person's interests, as if they were the advocate's own, thus bringing the person's gifts and concerns into the circles of ordinary community life. Friendship, social support, and social change can all emerge from these intentional relationships.

By supporting these ongoing, potentially life-long, relationships, citizen advocacy fosters a community where all people's gift's and talents can be shared and celebrated. "I have yet to encounter a safety net of laws, rules, regulations, and policies that was any stronger than a single, concerned and engaged person, standing shoulder to shoulder with a person, navigating the daily challenges of life in the community."
